

**AMENDMENT ONE TO THE
DATA SECURITY ADDENDUM SCHEDULE A

The following section 17 is added to the Data Security Addendum Schedule A dated May 9, 2019:

17. Consistent with the Florida Transparency in Contracting Initiative, the SBA posts certain operational contracts on its website, and this Agreement, as redacted and attached hereto as Exhibit A, will be one of the agreements posted. With the exception of any information, LogicManager has specifically identified and redacted from this Agreement as set forth in Exhibit A, LogicManager hereby agrees that the SBA is authorized to post this Agreement and a description of the contents of the Agreement on the SBA's website. In addition, the parties may from time to time during the term of the Agreement enter into one or more amendments or addenda to this Agreement. With the exception of any information LogicManager has specifically identified and redacted from any such amendment or addenda at the time LogicManager delivers an executed counterpart of such to the SBA, LogicManager hereby agrees that the SBA is authorized to post any such amendment or addendum and a description of the contents thereof on the SBA's website. LogicManager hereby understands, acknowledges and agrees that the redaction of any such information does not mean that such redacted information is protected from disclosure pursuant to a public records request under Chapter 119, Florida Statutes, or as otherwise required by law or a court or authority of competent jurisdiction.


