Separate and dedicated Access Code(s) will be created and used exclusively for CO and its specific application(s).

CO will have full access to the $FinxS^{(R)}$ Assessment Platform. It allows CO to access and manage all assessment data, re-order assessment results, create Job, Pair, Team and Organizational assessments, combine results across assessments, and perform real-time analysis of results using $FinxS^{(R)}$ Playground.

Extended DISC North America, Inc. provides CO with necessary support in setting up and using $FinxS^{\textcircled{R}}$ Assessment Platform and Extended $DISC^{\textcircled{R}}$ and $FinxS^{\textcircled{R}}$ assessments.
