AMENDMENT EIGHT TO THE CONTRACT FOR LEGAL SERVICES BY AND BETWEEN THE STATE BOARD OF ADMINISTRATION OF FLORIDA ("SBA") AND THE GROOM LAW GROUP, CHARTERED ("ATTORNEYS") SBA CONTRACT NO. 96-79

Pursuant to the provisions of Section 8 of the Contract for Legal Services (the "Contract") between the SBA and the Attorneys, the parties hereby agree to amend the Agreement as follows:

- 1. The existing Billing Rates Schedule hereby is deleted in its entirety and hereby is replaced in its entirety by the attached revised Billing Rates Schedule applying the 2021 Standard Rate less fifteen (15) percent.
- 2. The effective date of this Amendment Eight is July 1, 2021. This fee schedule shall remain in effect until June 30, 2023.
 - 3. Sections Nine and Ten are hereby added to the Contract as follows:
 - 9. Consistent with the Florida Transparency in Contracting Initiative, the SBA posts certain operational contracts on its website, and this Contract will be one of the agreements posted. Attorneys hereby agree that the SBA is authorized to post this Contract (including any amendments or addenda hereto) and a description of the content of the Contract (including any amendments or addenda hereto) on the SBA's website.
 - 10. Attorneys shall register with and use the E-Verify system to verify the employment eligibility of newly hired employees performing services within the United States in accordance with Section 448.095, Florida Statutes. Attorneys acknowledge that SBA is subject to and Attorneys agree to comply with Section 448.095, Florida Statutes, as amended from time to time, to the extent applicable.
 - 4. All other provisions of the Contract shall remain in full force and effect.
