AMENDMENT TEN TO THE CONTRACT FOR LEGAL SERVICES BETWEEN LEWIS, LONGMAN & WALKER, P.A. AND THE STATE BOARD OF ADMINISTRATION OF FLORIDA

SBA CONTRACT NO. 97-28

Pursuant to the provisions of Section 8 of the Contract for Legal Services ("Contract") between Lewis, Longman & Walker, P.A. ("Firm") and the State Board of Administration of Florida ("SBA"), the parties agree that the following changes shall be made to the Contract:

1. Section 2 hereby is deleted in its entirety and hereby is replaced in its entirety to read as follows:

Attorneys and paralegals, under the supervision of Attorneys, shall receive the compensation reflected in Attachment 1, Special Government Rates, to this Amendment Ten, which is attached hereto and made a part hereof. However, prior to the provision of any compensable services, the Attorneys and the SBA shall agree to a total maximum fee for any such service. Initially, the total maximum fee for each such matter shall not exceed \$20,000 without prior written authorization from the SBA. The Attorneys and paralegals shall not charge their hourly rate for travel time except to the extent that such time is spent working on SBA matters.

- 2. The Firm acknowledges that the SBA is subject to and the Firm agrees to comply with section 448.095, Florida Statutes. as amended from time to time, to the extent applicable.
- 3. Consistent with the Florida Transparency in Contracting Initiative, the SBA posts certain operational contracts on its website, and this Contract will be one of the contracts posted. The Firm hereby agrees that the SBA is authorized to post the Contract (including any amendments or addenda hereto) and a description of the content of the Contract (including any amendments or addenda hereto) on the SBA's website.
- 4. The SBA is bound by the provisions of chapter 119 (Public Records), Florida Statutes, and in the event of any conflict between chapter 119, Florida Statutes, and the terms of these Agreements between the parties, the provisions and procedures of chapter 119, Florida Statutes will prevail. In addition, in order for documents to be considered confidential by the SBA, the Firm must mark items as confidential or trade secret.

To the extent applicable, the Firm shall comply with chapter 119, Florida Statutes. In particular, the Firm shall:

- (a) Keep and maintain public records required by the SBA in order to perform the Services under this Agreement;
- (b) Upon request from the SBA's custodian of public records, provide the SBA with a

copy of the requested public records or allow such records to be inspected or copied within a reasonable time at a cost that does not exceed the cost provided in chapter 119, Florida Statutes or as otherwise provided by Florida law;

- (c) Ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law for the duration of the contract term and following the completion of the contract if the Firm does not transfer the records to the SBA when the Agreement is completed;
- (d) Upon completion of the Agreement, transfer, at no cost, to the SBA all public records in the Firm's possession or keep and maintain the public records required by the SBA in order to perform the services under this Agreement. If the Firm transfers all public records to the SBA upon completion of the contract, the Firm shall destroy any duplicate public records that are exempt or confidential and exempt from public records disclosure requirements. If the Firm keeps and maintains public records upon completion of the contract, the Firm shall meet all applicable requirements for retaining public records. The Firm shall, upon request from the SBA's custodian of records, provide all records that are stored electronically to the SBA in a format that is compatible with the information technology systems of the SBA.
- 3. IF THE FIRM HAS QUESTIONS REGARDING THE APPLICATION OF CHAPTER 119, FLORIDA STATUTES, TO ITS REQUIREMENT TO PROVIDE PUBLIC RECORDS RELATING TO THIS AGREEMENT, CONTACT THE CUSTODIAN OF THE PUBLIC RECORDS AT:
